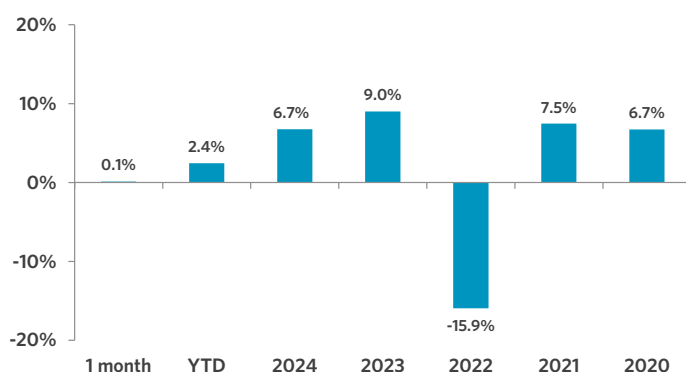

Cumulative returns (Class A - since inception, 12.08.2011)



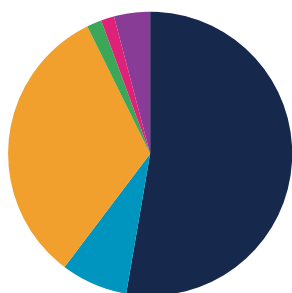

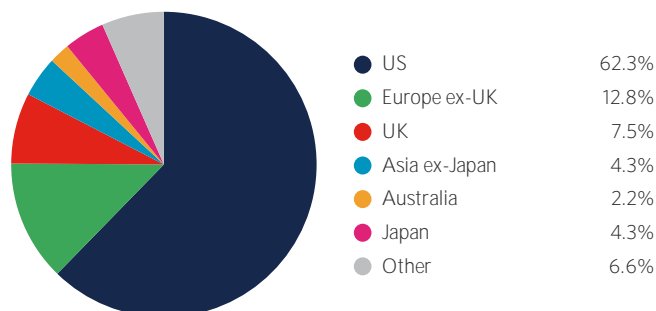

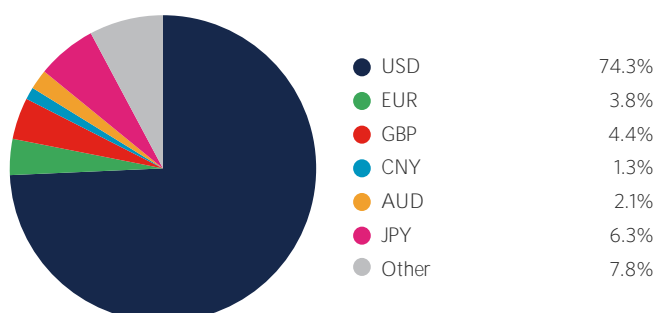
